Corporation Members and Friends,

As a newlywed, back in 1984, I was invited to join the Sierra View Corporation. Within a year or two, I found myself serving on the board of directors. This was back when the office was a little trailer on the edge of the parking lot, surrounded by a sea of weeds which was at least half of our campus. I spent many years as the board secretary, trying to summarize other people's thoughts as I recorded minutes.

Now 35 years on, some maturing has occurred. Sierra View Homes now has three licensed administrators: Ro Linscheid as Executive Director, Vito Genna as Assistant Executive Director and Jenny Penner as Assisted Living Administrator. We have 150 employees and a budget of over \$9 million.

One decision we made this past year stands out as having an unanticipated, but positive effect on Sierra View. We pursued an off-campus venture with a struggling, sister facility in Selma. As a board, executive officer, and some staff we assisted and guided them in development, management and operations of their facility helping them get back on a new track. What we took away from the experience is a very, old lesson; as professionals we must continue to learn, unlearn and relearn.

Last March, two board members attended Mennonite Health Assembly in Wichita, Kansas. In 2019, board members have committed to jumping into the trenches and joining quarterly, staff Quality Assurance/Performance Index meetings where discussion of risk management, performance improvement plans and goal setting takes place across all departments. A board member shared of a recent conversation with our prescription supplier representative who said our staff does exemplary work!

Your board and our staff are committed at many levels to continue to provide a great living experience and outstanding service to our residents. This is evidenced by testimonial letters, positive Google reviews and happy faces on 260 people who presently call Sierra View "home." It's demonstrated by State and Federal inspections, State Medi-Cal Incentive Award and a Medicare 5 star rating. However, there is no time to rest on our laurels. We need to learn how to utilize new tools of today: electronic record keeping, artificial intelligence and robotics, to solve pressing new and yet timeless, problems not only providing housing and care for seniors of the First Mennonite Church, but persons of many different denominations and faiths in our community and beyond. All the while realizing that the future approaches every second unimpeded. Thank you.

Resident Profile

During all of 2019 we were able to maintain a steady census throughout our community. There are waiting lists for all areas of Sierra View Homes Retirement Community.

Terraces and Garden Apartments

A total of 21 apartments changed hands through the course of the year. There are 115 independent living apartments ranging from a 479 sq. ft. Studio to a 1196 sq. ft. two-bed/two-bath apartment. On December 31, 2019 we had 134 residents in the Sierra View Residences. Of the 134 residents, there are 96 women and 38 men. We have 22 couples on campus.

Nursing Care Center

Our Nursing Care Center provides ongoing care for people who need 24 -hour, 7 days-a-week care. We provide Medicare A rehabilitation for success in returning to prior level of function following a surgery, fracture, and/or other issues that can be debilitating to a person. We have been fortunate to maintain a good census throughout 2019. Through therapeutic and skilled care 64 were discharged to their home or lower level of care.

Residential Care/Marden's Place

On December 31, 2019, Sierra View Homes Assisted Living had 34 in Residential Care. All 21 large rooms were rented as singles and all 15 small rooms were also occupied.

In Marden's Place, 5 shared rooms and 8 single rooms were occupied according to the census for December 31, 2019. The census showed 17 people, 3 men and 14 women living in Marden's Place.

Jenny Penner, Administrator; Estella Pena, RN; and Cecilia Barraza, LVN provide leadership and clinical care to all residents in Residential Care and Marden's Place.

Financial Health

The financial health of Sierra View Homes Retirement Community remained strong for 2019. The result of a full census, a Medi-Cal Incentive Award, and positive distribution from our Everence Mutual Funds created an increase of \$490,625 in net assets. The Annual Audit was verified by Jeffrey Carter, CPA and reviewed by the Sierra View Homes Board of Directors. The results allowed for a minimal rate increase for 2020, an enhancement of the Residential Assistance Fund and an investment in our Capital Campus improvement.
