We are hopeful that vacancies will continue to decrease and we will again achieve a stable and routine way of life on our campus.

And normal change continues. Three two-term board members leave us this year; Larry Harder, Irvin Isaak and Ted Loewen. Their experience with the board and knowledge of Sierra View will be seriously missed. As our Nominating Committee, they have worked hard to secure three replacement members who will be introduced to you at the Annual Corporation meeting.

This report is submitted to you with hope for the future. We will continue to feel the effects of our challenges from last year but we are full of hope for the future of Sierra View Homes. "In the company of friends" we will go forward together.

Long ago Thomas Paine wrote, "I love the person that can smile in trouble that can gather strength in distress and grow." As an organization, Sierra View Homes Retirement Community certainly stood the test of 2020. Grounded in the enduring principles of compassion, care and resilience the Sierra View Staff continued to work our way through the ongoing crisis caused by the Coronavirus and a very trying year.

The first half of the year saw through a smooth transition of leadership as Ro Linscheid assumed the role of CEO. We were able to care for residents at full capacity and send many home or to a lower level of care after rehab.

The last half of the year saw our wider community and this retirement community grapple with the full brunt of the Coronavirus. Dealing with lockdowns, loss of revenue, and two major waves of the virus on campus (one in July and the other in December). Staff dealt with stress and were taxed to the maximum in trying to keep residents and themselves safe. Our revenue dropped due to a decline on our census and the inflated costs of preventative protection equipment and the continual testing.

Managers worked together to keep spirits up and productivity from declining. Financial assistance from the Federal Payroll Protection Plan grants certainly allowed us to pull through without financial losses.

The Sequoia Welcoming Room was finished in spite of the cost increases, delays due to government inspections, inclement weather and COVID restrictions. Today our residents can enjoy a spectacular gathering point on our campus.

Perhaps the most difficult part of this year was the saying goodbye to residents subjected to isolation from families and friends. The lockdown demanded by the disease management and government dictates were devastating to so many residents. We are proud of how our staff continued to engage with our residents and smile through their own troubles and be the consistent friend.

We look forward to rebuilding our resident base, building on our strong foundation, continue with our hopeful Christian ministry and provide the best possible caring and healing environment for 2021 and beyond.

The financial health of Sierra View Homes Retirement Community continues to be in good shape in spite of the 2020 COVID Pandemic and the capital expense of \$1.2 million for the Sequoia Welcoming Room. The annual audit was verified by Jeffery Carter, CPA and reviewed by the Board Audit Committee. Certainly a positive distribution from our Everence Mutual Funds and a 2% help2 loan from the California State Treasury helped. The damage from the pandemic was partially covered by the Payroll Protection Plan and the Health and Human Services Federal Pandemic Relief Funds. 2020 was a difficult year for all long-term care communities with its lockdowns and census count declines but given our campus reserves and long-term committed staff, Sierra View Homes will continue to serve the Central Valley Community well.

# **Resident Profile**

All health care and retirement community living were affected by the COVID-19 pandemic. Starting in March, federal, state and local health officials pushed through a volley of mandates and dictates have had consequences on congregate living. Lockdowns, viral spreads, reporting requirements all equated to slowing resident census at all levels on campus.

# **Terraces and Garden Apartments**

There are 115 Independent Living apartments on campus: 52 in the Terraces and 63 Garden Apartments. We had a little more turnover this year but remained full through the year. Nearly 20% of the apartments were rented by couples. An apartment was temporarily used to house staff who were working in the Skilled Nursing COVID unit.

# **Nursing Care Center**

Our Nursing Care Center provides ongoing care for people who need 24-hour, 7 days-a-week care. We provide Medicare A rehabilitation for success in returning to prior level of function following a surgery, fracture, and/or other issues that can be debilitating to a person. In 2020 114 people were admitted to the Nursing Care Center throughout the year. Thirty-eight went to a lower level of care or went home after their skilled stay.

Therapy is offered as an optional service from our skilled nursing facility. People can access outpatient, physical therapy occupational and speech therapy through our rehabilitation center. Nursing home residents also receive restorative therapy on an ongoing basis.





# **Residential Care/Marden's Place**

Jenny Penner, Administrator, Estella Pena, RN, and Cecilia Barraza, LVN provide leadership and clinical care to all residents in Residential Care and Marden's Place. On average, each day we have 40 to 45 residents in Assisted Living, and 19 to 21 resident in Marden's Place. The Assisted Living nursing staff also lends clinical support to our Independent Living residents on campus.
